Old Business:

- Jason Ward Poultry Land Development Union Township No new updates.

- Dietrich's Milk Plant Solar Project Kaye gave an update.
 - We have received the building and floodplain permits from Linden. She is working on getting long term resource decommissioning information to have on file.
 - It was requested that Linden supply a letter with information on who is holding the bond/escrow for the decommissioning and the percentage of funds and how often it is being bonded.
 - o Approval was given for construction to begin.
- Sky King Fireworks Lawrence Township Kaye gave an update:
 - Waiting for confirmation of the completion of preliminary conditions.
 - o It was asked to have the representatives come to another meeting. There are still some unanswered questions concerning lighting and signage.
- Meads Wedding Venue Brookfield Deb discussed the wedding venue that was constructed without following the Land Development process. An agricultural permit for a barn was originally provided. Deb will send a letter of violation and request they begin the LD process.

New Business:

- PGE 596B Compressor Station Liberty Ryan Elsey & Ben VanOrd presented. They are constructing (2) 36x40 compressor buildings on DCNR land. They are looking for preliminary approval. Roger made motion to approve, second by Bill Roosa
 - Noise study was done and is in compliance with DCNR's regulations at 50db.

- Kevin asked about the lightening and was advised that there will be no external lightning at the site.
- They will provide us with a statement of approval from DCNR stating there will be no external lighting.
- Waivers were given for the HOP as the access road is a private DCNR road and screening will not be required as there are no close residential neighbors.
- By-Laws A template of Planning Commission by-laws was handed out. Deb will begin working on and have something to review at the next meeting.
