Where the property is located in two or more taxing authorities, the person recording the deed shall indicate there on the value of the property in each taxing authority for local realty transfer tax purposes.

ALL deeds, mortgages and assignment of mortgages must have a **Certificate of Residence completed and signed** in order to record.
