<u>Old Business:</u> Kaye gave the following updates:

- Jason Ward Poultry Union Township No new updates, Crystal was waiting to see if the grass will grow after the heavy rains. Once she is happy with the grass, she will schedule the NOT inspection.

- Meads Wedding Venue Brookfield Spoke with Mr. Mead on 10/12/21, he is waiting to hear from DEP on sewage approval. Waiting on the Conservation District to hear about the E&S plan. He is struggling to find a surveyor to do the plan.
- PGE 596B Compressor Station Liberty Construction Phase.
- Stonewall Pork Received an email from TeamAg, they are working on getting the As-builts and NOT completed. The Township is working to get a site permit for Assessment.

New Business:

- By-Laws Discussion continued. Terms will remain for 3 years. There will be a final review at the next meeting in November.
- Land Services Group is requesting a waiver of design criteria to allow the side lot setbacks to be 5 feet rather than the 10 feet requirements of SALDO. This is to rectify a house being over a neighbor's property line in Gaines Township. Waiver was approved/granted by roll call vote.
