The County also has reserved the right to take back ownership of the equipment should the University, or the Department, etc. go defunct in the future – or some similar circumstance: \$11,041.19 (Act 13).

Purchase of 12 Turbo Draft water eductors for fire depts. A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve the purchase of 12 Turbo Draft water eductors for those County fire departments that have expressed an interest. These will take the place of dry hydrants. Each interested fire department has committed a \$500.00 match towards the cost of the Turbo Draft. The County's share is \$2,275 per Turbo Draft, total \$27,300 (Act 13).

Agreement w/Brico
