Hamilton and unanimously carried upon vote of three ayes and no nays to approve an agreement between Tioga County and the Deane Center for the Performing Arts, Inc., approving 48% of the square footage of the real estate owned by the Deane Center shall be exempt from property taxation and the remaining 52% shall be subject to regular property taxation. This allocation shall apply for tax years 2012 through 2016. Upon expiration of this agreement, the property shall return to full taxable status.

Selected employees in these departments will become employees of SAM, Inc. Fee for FY 2014/2015: \$1,481,250; Fee for FY 2015/2016: \$2,025,000.

Bunn and unanimously carried upon vote of three ayes and no nays to approve an amendment to the agreement between County of Tioga and EADS Architects, for the project "Renovations and Improvements to the Tioga County Dept. of Emergency Services Facility". Additional professional services for the design, construction contract amendments and implementation of revisions, modifications and improvements to the existing building and site construction, \$13,900 (Act 13).

Agreement w/ InterAct for CAD system A motion was made by Roger C. Bunn, seconded by Mark L. Hamilton and unanimously carried upon vote of three ayes and no nays to approve a Master Purchase, License & Services Agreement with InterAct to upgrade the County's Computer Aided Dispatch system for the Dept. of Emergency Services, \$141,675. This cost is within the project budget (Act 13).

Agreement to purchase dispatch system from Potter Cty A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve an Agreement for Provision of ACOM Radio Dispatch Control System between Tioga County and Potter County, for use in the 911 center, \$30,135.11 (Act 13).

Purchase 911 phone system from Zetron A motion was made by Roger C. Bunn, seconded by Mark L. Hamilton and unanimously carried upon vote of three ayes and no nays to approve the purchase of Zetron Max Calltaking system (911 Emergency Phone System), \$282,682.75. This cost is within budget (Act 13).

Purchase radio dispatch system from Zetron A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve the purchase of the Zetron ACOM EVO 911 radio dispatch console system, \$215,779 and the Zetron KVM system which allows the use of only one keyboard and one mouse for all computers at each console position, \$18,540. The total cost for the two purchases is \$234,319 and is \$151,672.34 under budget (Act 13).

Approve future purchases of radio dispatch system upgrades

13 Agreements/ Amendments for DHS A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve the future purchase of the Zetron ACOM upgrade for a cost not to exceed \$89,347 and a future purchase of the ACOM Radio Gateways for a cost not to exceed \$187,350. These two future upgrades will allow Tioga County to upgrade the radio dispatch system when the enhancements become available in 2015 and will permit the county to have the most up to date technology and have an extended life for the system (Act 13).
