**Business:**

Following up on the Opioid Settlement proposal from Harbor requesting drug testing kits for the jail for individuals going to outpatient treatment. It was mentioned that there is a grant that is used to purchase these test kits however a small population qualifies for this grant. No questions/concerns.

The SCA has created 4x6” magnetic parent resource cards that have QR codes on them. These resources include reliable information regarding substances, talking to teens, internet, and social media safety, etc. We will bring this resource to events to hand out to parents in the community. Our prevention team must submit a yearly plan and it has been approved for 2024/25. We are receiving the gambling grant in July. With this grant, they asked for a 5-year plan. That plan has been submitted and we are waiting for that to be approved.
