PA SAVIN agreement

A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve a PA SAVIN (PA Statewide Automated Victim Information) maintenance agreement between the PA District Attorneys Institute and Tioga County for the period 1/1/2020 – 12/31/2020. The PA SAVIN System provides notifications to crime victims, such as the release from custody or transfer from one facility to another of persons held in custody.

Delta Development agreement A motion was made by Roger C. Bunn, seconded by Mark L. Hamilton and unanimously carried upon vote of three ayes and no nays to approve a two-year agreement with Delta Development Group for continued consulting services for the Marsh Creek Greenway project. Monthly retainer fee for first six months - \$14,000; monthly fee for the remaining 18 months - \$8,500. Act 13 Legacy Fund.

Motorola Solutions agreement A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve a one-year radio maintenance agreement with Motorola Solutions. Will be paid from the 911 account.

Bridge Transfer Reimbursement agreement for Marsh Creek Greenway A motion was made by Roger C. Bunn, seconded by Mark L. Hamilton and unanimously carried upon vote of three ayes and no nays to approve a Bridge Transfer and Reimbursement Agreement with Tredyffrin Township, Chester County. The historic pin-connected Warren pony truss bridge, constructed in or about 1879, will be transported to Tioga County, for use on the Marsh Creek Trail. Tioga County will reimburse Tredyffrin Township for certain costs related to the removal, coordination, loading, transport, and off-loading of the bridge trusses to a designated location in Tioga County. Total costs are estimated to be approximately \$200,000. The Township has a grant which will reimburse them 80% of the costs. Tioga County will reimburse the Township 20% of the actual total costs. A Pa DOT Multimodal grant will reimburse Tioga County's cost.

Enterprise Fleet Leases for Probation and Sheriff A motion was made by Mark L. Hamilton, seconded by Roger C. Bunn and unanimously carried upon vote of three ayes and no nays to approve the following five-year leases with Enterprise Fleet Management: Probation Dept. – 2020 Chevrolet Tahoe, \$771.01/month; 2020 Chevrolet Traverse, \$622.35/month; 2020 Jeep Grand Cherokee, \$595.31/month. Sheriff Dept. – two 2020 Ford Police Interceptor Utility vehicles, \$766.31/month, each.
