WHEREAS, Pennsylvania's correctional system is the oldest in the nation, evolving from the establishment of Philadelphia's Walnut Street Jail in 1773 and the Eastern Penitentiary in 1829; and

WHEREAS, the "Pennsylvania System", as it became known, was the leading influence in the development of penology throughout the 19th Century and the forerunner of modern corrections; and

WHEREAS, today, Pennsylvania faces continued difficult challenges in corrections. With twenty-three state correctional institutions, one training academy, two central office buildings, ten community corrections centers, twenty-three contract facilities, one motivational boot camp, sixty-three county prisons and jails and ten federal facilities and offices, our correctional facilities house approximately 73,350 inmates; and

WHEREAS, the secure and safe operation and management of those facilities rests in the hands of nearly 31,500 trained, skilled, and dedicated corrections professionals. They are corrections administrators, corrections officers, counselors, treatment specialists, educators, clerical support staff, business administrators and purchasing agents, personnel and labor relations specialists, re-entry specialists, social workers, clergy, medical professionals, food service specialists, computer technicians, parole agents, parole supervisors and administrative positions, planners and research analysts, and skilled craftspeople upon whose skills, efficiency, and professionalism the functions of the Pennsylvania correctional system depends; and

WHEREAS, although each of these dedicated professionals works in a different field and specializes in a specific area, all are committed to a common goal: the secure, safe and humane operation of our commonwealth's correctional facilities where employees work to reduce future crime through the delivery of programs to change an individual's criminal behavior; and

Whereas, the USS Liberty AGTR5, a US Navy intelligence gathering ship, was operating in international waters off the Sinai Peninsula on June 8, 1967; and

Whereas, the Israeli/Arab 6-day War was in progress; and

Whereas, the USS Liberty was clearly marked and flying the American flag; and

Whereas, Israeli military forces, strafed, napalmed and torpedoed the USS Liberty at will with only token resistance from Liberty machine guns; and

Whereas, the commanding officer, Captain William L. McGonagle, and the valiant crew attempted to save the ship from total destruction while awaiting US Navy assistance; and

Whereas, the fighter aircraft launched from the USS Enterprise to rescue the Liberty were recalled under orders from Washington; and

Whereas, 34 non-combatant men, military and civilian, lost their lives in the performance of their duty as well as 172 wounded; and

Whereas, the Israeli government labeled this assault on a US Navy ship as an "accident" and "mistaken identity" even though the USS Liberty was clearly marked with hull markings and flying the American flag in a stiff breeze; and

Whereas, the US Navy and National Security Agency intelligence chiefs familiar with this unprovoked attack by an "allied government" have stated unequivocally that Israeli forces had clearly identified the Liberty.

Therefore, be it resolved, that the Tioga County Commissioners do hereby declare June 8, 2022 as "Remember the USS Liberty Day" and order the flag at the Tioga County Courthouse and other County facilities to be flown at half-mast in memory and support of the officers, crew and their families.

RESOLUTION BY THE TIOGA COUNTY BOARD OF COMMISSIONERS REQUESTING APPROPRIATE FUNDING TO SUPPORT THE CRUMBLING MENTAL HEALTH SYSTEM IN THE FY 2022-2023 STATE BUDGET

WHEREAS, counties provide essential community-based mental health services such as crisis intervention, community residential programs, family-based support and outpatient care, which are critical to the well-being of our constituents and our communities; and

WHEREAS, as the providers of community-based mental health services, counties are seeing demands for mental health services in communities that far exceed state funding levels and without adequate and sustainable funding, counties may not be able to meet the mental health needs of some of our most vulnerable residents; and

WHEREAS, in 2012 the commonwealth cut \$84 million that counties used to fund programs for people with intellectual disabilities, mental health challenges, and other needs forcing programs to close and putting the human services system into a vulnerable state; and

WHEREAS, the membership of the County Commissioners Association of Pennsylvania (CCAP) made the top priority of the association's advocacy in 2022 the "Appropriate Funding to Support the Crumbling Mental Health System"; and

WHEREAS, state funding has lagged far behind needs and caseloads for years, which has negatively affected services while also putting tension on communities and local budgets; and

WHEREAS, the Center for Rural Progress published a report on Suicide Trends and Prevention in Rural Pennsylvania Counties and Schools and key findings included the steep rise in suicides in Pennsylvania over the past two decades and that the increase was greater in rural communities; and

WHEREAS, Governor Wolf's initial budget proposal included supporting the behavioral health needs of Pennsylvanians by investing \$36.6 million additional funds in county mental health base funds on top of \$75 million in federal funds for recruitment and retention payments to qualifying home and community-based service providers, as well as \$18.8 million to provide services for individuals with intellectual disabilities and/or autism currently on the emergency waitlist; and

WHEREAS, Tioga County has invested in community-based mental health services that coordinate and invest in programs and services that meet the needs and challenges of local communities; and

WHEREAS, counties will need collaboration between the legislature and administration to work closely with them on a targeted, strategic investment of dollars into community mental health services at the county level in order to continue the existing safety net and bolster the availability of mental health services to those who need them as vital steps in the right direction.

NOW, THEREFORE, BE IT RESOLVED, that the Tioga County Board of Commissioners do hereby support an increase in funding for community mental health base programs in accordance with the priorities of the County Commissioner Association of Pennsylvania by the General Assembly and Administration; and

BE IT FURTHER RESOLVED, that the Tioga County Board of Commissioners will submit this resolution and accompanying letter of support to the regional state representatives and senators, and provide copies to the state Department of Humans Services and the Governor's office as well as regional commissioners in an effort to respectfully request the administration and General Assembly take steps to address our crumbling mental health system.
