- All Local Emergency Management Coordinators (LEMCs) <u>MUST</u> be approved through the following process:
 - Step 1 Local Municipality Requests to Appoint LEMC
 - Step 2 County EMA Approves
 - Step 3 PEMA Approves
 - Final Step Governor's Office Appoints LEMC

LEMC Status Checklist Appointments

- Municipalities will receive letters in January with the status of their LEMC appointment
- Any municipalities who have not submitted appointment letters to the County by then will be <u>HIGHLY</u> encouraged to do so

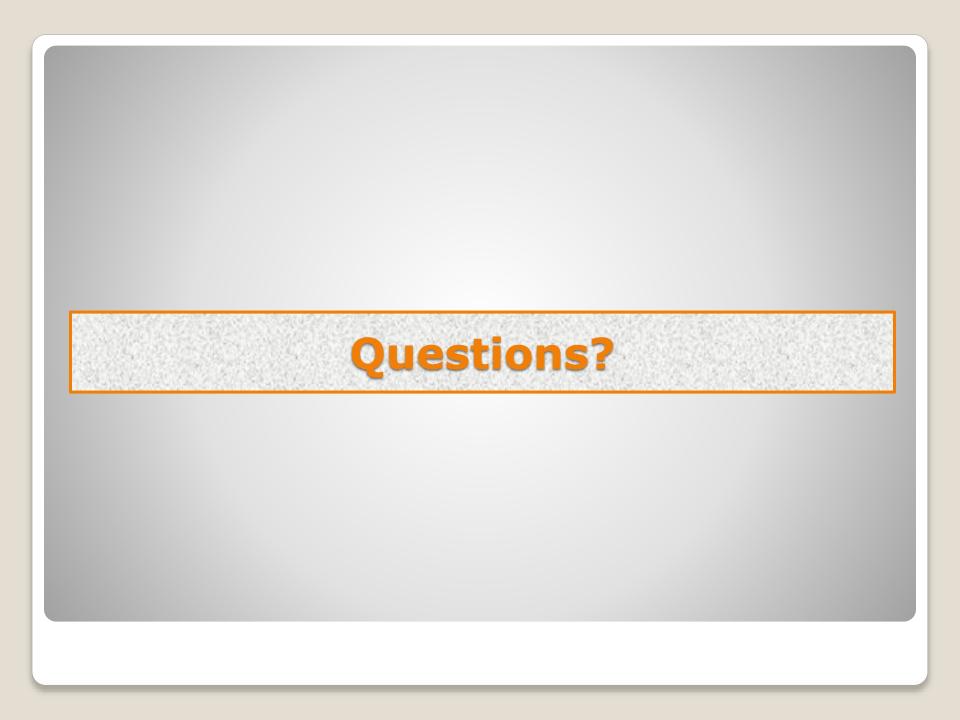
- Radio IDs
 - EOC = (Full Municipality Name)
 - LEMC = (Municipality #) 81
- VHF Very High Frequency
- Possible vendors
 - Motorola, Kenwood, Harris
 - "P-25 Capable" or even "P-25 Compliant"

- Knowledge Center (KC)
 - Situational Awareness Platform
 - All facilities, personnel, and equipment should be entered in to KC
 - Can request resources/assistance through KC
 - Get informational alerts through KC

- EPFAT Emergency Power Facility Assessment Tool (Handout)
 - ALL backup power generators that service critical facilities should be entered into EPFAT
 - Borough/Township Buildings
 - EOCs
 - Polling stations
 - EMS/Fire/Law Enforcement Stations
 - Schools (being done separately)

- TRAIN PA (Handout)
 - Commonwealth Damage Reporter (CDR)
 - PA Damage Reporter Module 101 Damage Reporting Overview (1 hour) Course ID: 1068043

 - EVERY LEMC should be signed up
 - EVERY municipality should be signed up
 - Send alerts regarding
 - Garbage pickup
 - Road closures
 - Public Notices
 - Post-Disaster information



Notification and Resource Manual (NARM)

- FEMA Links (Handout)
 - Step 1 Type Resources
 - Personnel, Organizations, Equipment
 - Step 2 Enter resources into Knowledge Center (KC)
 - Step 3 Print off one paper copy for LEMC and one for EOC

Notification and Resource Manual (NARM)

- TCDES Intern to start in January. Will also try to capture:
 - Vendors
 - Tree Trimmers
 - Waste Haulers
 - Backhoe providers
 - Backup power providers
 - Etc.

Response Operations Plan (ROP)

- Draft will be available by end of November for your review
- Please try and have municipalities adopt by December 31, 2017!!

Winter Storm

- LEMC Responsibility BEFORE a Winter Storm
 - Preparedness messaging
 - Start tracking staff time
 - Start tracking resources available (e.g., salt, dump trucks, plows)

Winter Storm

- LEMC Responsibility DURING a Winter Storm
 - Situational Awareness
 - Report road statuses up to County
 - Report when roads are closed/impassable
 - Report when running low on salt
 - Monitor power outages
 - Are critical facilities impacted?
 - Are individuals with functional needs impacted?
 - (e.g., individuals on Oxygen, elderly, etc.)

Winter Storm

- LEMC Responsibility AFTER a Winter Storm
 - Public Messaging
 - Where to get assistance during long-term power outages
 - Realistic expectations of when roads will re-open
 - Damage Assessments (if applicable)
 - Snowfall reporting
 - Compiling municipal expenses
 - Staff time
 - Equipment and Supplies (Standard FEMA Rates)

 - Childcare Centers
 - Extended Care Facilities (i.e., Nursing Homes)
 - Local Municipalities
- Where?
 - From your municipality
