



## BRADFORD / TIOGA COUNTY RESIDENTS

The Chemung County Sheriff's Office will now accept applications for Bradford / Tioga County residents who work, own property or a business in Chemung County or are current or retired Law Enforcement or frequently do business within Chemung County. Pistol Permits in Chemung County are issued by Chemung County Court Judges not the Sheriff's Office, we simply facilitate the application process. You must have a compelling reason to submit an application if you don't fall under one of the aforementioned categories. You must have some type of geographical jurisdiction to apply and be considered.

The pistol permit application process is governed by New York State Penal Law Section 400.00.



## BRADFORD / TIOGA COUNTY RESIDENTS

If you are checking Box #5 “Geographical Jurisdictional Issue” please write in the line the reason you are requesting said permit, an example a geographical jurisdictional issue would be as follows:

- I currently possess a PA Pistol Permit and regularly travel back and forth from Pennsylvania into New York to conduct daily business.
- I purchase farm/household supplies in Chemung County as there are no businesses in Bradford / Tioga County that offers the needed items.
- I travel to Chemung County on a regular basis in order to conduct personal business, as I have family members and friends who reside in Chemung County.

*These are the types of explanations that should be submitted when applying for your permit. Explanations such as “shopping”, “because it’s my right” and etc. will most likely not be approved by the County Court Judge.*
