**Business:**

There have not been any updates regarding Opioid Settlement Dollars this month.

Our Outreach and Prevention team is beginning to plan a Fall Fun Night at the Wellsboro School District. We are partnering with Drug Endangered Children (DEC) to host a roller skate night in Tioga. We have attended several fairs and community events this summer to continue our outreach efforts. At these events we are dispersing information and educating our communities. The Single County Authority (SCA) submitted a request to the Department of Drug and Alcohol Program (DDAP) for additional State Opioid Response dollars to assist with Student Assistance Program (SAP) trainings. Our prevention team is hosting a vaping workshop on September 25<sup>th</sup> at the Wellsboro Area High School for students and parents. According to the Pennsylvania Youth Survey (PAYS) data, vaping has increased for our county.

The Behavioral Health Alliance of Rural Pennsylvania (BHARP) has a few training opportunities coming up: American Society of Addiction Medicine (ASAM) Third Edition training for new providers and a mental health/substance use disorder crisis 3-hour

virtual training for registered nurses.
