Hamilton and unanimously carried upon vote of three ayes and no nays to approve a proposal from T3 Global Strategies for flyover photogrammetric services for the Tioga County dispatch area, \$65,000, for use by Emergency Services and GIS Department.

Agreement w/Fire Alarm Service Tech.

Coolidge and unanimously carried upon vote of three ayes and no nays to approve an agreement between Tioga County Prison and Fire Alarm Service Technology, Inc. for equipment and installation of a new fire alarm system, \$54,386; one year fire alarm service agreement, 4/8/15 - 4/7/2016, \$2,375.

Agreement w/ MSA Systems Integration A motion was made by Erick J. Coolidge, seconded by Mark L. Hamilton and unanimously carried upon vote of three ayes and no nays to approve an agreement with MSA Systems Integration to provide and install new security system software for the Courthouse, 911 Center, Tioga County Prison, and District Justice offices in Elkland and Mansfield. Integration of surveillance system with existing security system, \$4,776.80. Total cost: \$78,595.44 – Act 13 Funds.

Adopt Resolution R-4-15 Fair Housing Resolution R-4-15

LET IT BE KNOWN TO ALL PERSONS of Tioga County that discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, ancestry, sex, national origin, handicap or disability is prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the Pennsylvania Human Relations Act. It is the policy of Tioga County to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, ancestry, sex, national origin, handicap or disability, or familial status (families with children). Therefore, Tioga County does hereby pass the following resolution.

BE IT RESOLVED that within available resources Tioga County will assist all persons who feel they have been discriminated against because of race, color, religion, ancestry, sex, national origin, handicap or disability or familial status (families with children) to seek equity under federal and state laws by filing a complaint with the Pennsylvania Human Relations Commission and the U. S. Department of Housing and Urban Development.

BE IT FURTHER RESOLVED that Tioga County shall publicize this Resolution and through this publicity shall cause owners of real estate, developers, and builders to become aware of their respective responsibilities and rights under the Federal Fair Housing Law, the Pennsylvania Human Relations Act, and any local laws or ordinances.

FURTHER PUBLICITY will at a minimum include, but not be limited to: (1) the printing and publicizing of this resolution and applicable fair housing information through local media and community contracts; (2) distribution of posters, flyers, and any other means which will bring to the attention of those affected, the knowledge of their respective responsibilities and rights concerning equal opportunity in housing.
