#### TIOGA COUNTY FIREMEN'S ASSOCIATION INCORPORATED

CONSTITUTION AND BYLAWS (red is changes)

Ar. 1 Title and Mission Statement

Section I. This organization shall be known as the TIOGA COUNTY FIREMEN'S ASSOCIATION INCORPORATED.

Section II. The purpose of this organization is the rendering of mutual aid, promotion of safety and training of all member organizations and the establishment of communications, standards, guidelines and procedures to better promote relationships among fire, rescue, ambulance, and emergency services organizations serving Tioga County.

#### Article 2 Membership

Section I. A. This association shall include the fire departments, rescue and ambulance organizations providing service for any part of Tioga County. Fire Brigades in order to be eligible for membership must be located within the contracted fire protection boundaries of member fire departments.

This association shall include the fire departments, rescue and ambulance organizations providing service for any part of Tioga and Potter Counties being dispatched by Tioga County 9-1-1. Fire Brigades in order to be eligible for membership must be located within the contracted fire protection boundaries of member fire departments.

### Article 8 Application for Membership

Section I. Any fire department, ambulance service and or rescue squad or fire brigade supplying services to any part of Tioga County may be entitled to membership in this association, having paid the annual dues fee set by the membership and having furnished evidence that they can meet the standards of this association. The application fee shall be returned in full if the application is rejected from membership. The application for membership must be presented at a regular meeting and shall be voted upon in the next regular meeting. An application must receive a two-thirds (2/3) favorable vote of members present at voting.

Any fire department, ambulance service and or rescue squad or fire brigade supplying services to any part of Tioga or Potter Counties being protected by Tioga County 9-1-1 may be entitled to membership in this association, having paid the annual dues fee set by the membership and having furnished evidence that they can meet the standards of this association. The application fee shall be returned in full if the application is rejected from membership. The application for membership must be presented at a regular meeting and shall be voted upon in the next regular meeting. An application must receive a two-thirds (2/3) favorable vote of members present at voting.
