4,331 voted by an absentee/mail-in ballot

70 Provisional ballots were counted at final count and 14 denied for not being registered in Tioga County Total Ballots Cast: 21,718 out of 27,195 registered voters

The election office received approximately 501 phone calls on election day.

The poll lines went very smoothly and the Poll workers did a great job with the number of voters who came out and participated. The voters that we have heard from were very happy with the process and the poll worker's professionalism. We'd like to thank all of the poll workers in Tioga County for doing an amazing job!
