- IF YOU AND THE OTHER PARENT HAVE AGREED TO MODIFY AN EXISTING CUSTODY ORDER, YOU WILL NEED THE 'CUSTODY MODIFICATION AGREEMENT SELF-HELP PACKAGE.'
- IF YOU WANT TO FILE A NEW CUSTODY CASE AND NO CUSTODY ORDER IS IN EFFECT YET, YOU WILL NEED THE 'CUSTODY COMPLAINT SELF-HELP PACKAGE.'
- IF YOU AND THE OTHER PARENT HAVE AN AGREEMENT ON HOW CUSTODY SHOULD BE HANDLED, BUT THERE IS NO CUSTODY ORDER IN EFFECT YET, YOU WILL NEED THE 'NEW CUSTODY AGREEMENT SELF-HELP PACKAGE.'
- IF THERE IS ALREADY A CUSTODY ORDER IN EFFECT AND YOU WANT TO RELOCATE WITH YOUR CHILD(REN), YOU WILL NEED THE 'RELOCATION SELF-HELP PACKAGE.'
- IF THERE IS ALREADY A CUSTODY ORDER IN EFFECT AND THE OTHER PARENT HAS VIOLATED THE EXISTING CUSTODY ORDER, YOU WILL NEED THE 'CONTEMPT PETITION SELF-HELP PACKAGE.'
- IF YOU CANNOT AFFORD TO PAY THE FILING FEES FOR A CUSTODY CASE AND YOU NEED TO ASK THE COURT TO WAIVE THE FILING FEES, YOU WILL NEED THE 'IFP PETITION SELF-HELP PACKAGE.'

#### **INSTRUCTIONS:**

#### STEP 1: COMPLETE THE PETITION TO MODIFY CUSTODY

Complete the fill-in-the-blank Petition to Modify Custody included in this package. On the top of the first page, fill in the names of the Plaintiff and the Defendant and the docket number exactly as they appear on the existing custody order. Whoever is listed as the Plaintiff in the existing custody order is still the Plaintiff, and whoever is listed as the Defendant in the existing custody order is still the Defendant. However, for the purposes of this petition to modify, you are the 'Petitioner' and the other party is the 'Respondent.'

The caption at the top of the page should look something like this:

#### **How to fill out the rest of the Petition to Modify Custody:**

<u>Page 1, Question 1</u> – Identify the child(ren) using their initials and their year(s) of birth. You should not use children's actual names or dates of birth anywhere on this form. If two or more children have the same initials, add a number or other appropriate extra character to differentiate them. Try to make your use of initials consistent with the prior court order and with other prior court documents relating to the same children. Here is an example:

If there are more than four children, check 'Yes' and list each additional child's initials and year of birth in the margin as neatly and clearly as possible or on a separate sheet.

<u>Page 1, Question 2</u> – Fill in your full name, address, phone number, and your relationship to the child(ren). Here is an example:

Notes: If you are a victim of abuse or domestic violence you can keep your address confidential, but you will still need to provide an address where the court and the Respondent can send legal papers to you. It does not need to be your residential address. Please also note that phone numbers are not required, but they make it easier for the court to contact the parties if necessary to discuss scheduling matters. For example, if there is a last-minute postponement of your court hearing and you do not provide a phone number, then the court will not be able to let you know.

<u>Page 1, Question 3</u> – Fill in the other parent's full name, address, phone number, and their relationship to the child(ren). Here is an example:

<u>Page 2, Question 4</u> – Sometimes more than two people are involved in a custody case. For example, grandparents and other third-parties are sometimes permitted to file for custody against the parents. If more than two people were named as parties to the prior custody order, then every other named party must be listed as a Respondent to your petition. That is true even if someone has had minimal or no involvement with their child(ren) since the order was entered. You cannot simply ignore any other named party or leave them out of the process. The only exceptions are when parties are deceased or their legal rights have been completely terminated by prior court order. If there is more than one respondent, you should check "Yes" to Question 4 and list the name, address, phone number, and relationship to the child(ren) of each additional respondent either in the margin of the page or on a separate additional sheet of paper.

Page 2, Question 5 – You should normally attach a copy of the prior custody order to your petition. However, the Public Access Policy of the Pennsylvania Unified Judicial System, effective January 6, 2018, prohibits the filing of documents that include children's full names or dates of birth. Custody Orders from before the effective date of the new policy may include this prohibited information. That means that if you attach a copy of a prior custody order that includes the name or date of birth of any child, you need to redact that information. If you have any questions or concerns about how to prepare a redacted copy of the custody order, it may be better just to file your petition without a copy of the previous custody order. The court should still have access to the original custody order and in light of the complications caused by the new policy, the court will probably excuse the omission. <u>Page 2, Question 6</u> – State your reasons for seeking a modification of the current custody order. The court will mainly be interested in things that have changed since the current order was entered. Remember to use initials instead of names to refer to the child(ren). Please also remember that the public can access this document after you file it, so use your best judgment and discretion when providing sensitive details about your situation and your child(ren)'s situation.

<u>Page 2, Question 7</u> – State as specifically as possible what changes you would like the court to make to the current custody order.

Page 3, Certificate of Compliance with Public Access Policy — By signing and filing the Petition to Modify Custody, you are certifying that it complies with the Public Access Policy of the Unified Judicial System of Pennsylvania and does not contain any (1) social security numbers, (2) financial account numbers, (3) driver's license numbers, (4) state identification numbers, (5) minor's names or dates of birth, (6) abuse victim's addresses or other contact information, as defined by Pa.R.C.P. No. 1931(a), except for victim's name. That policy is the reason why children can only be referred to by their initials. For more information, visit:

Page 3, Praecipe for Self-Representation — In the 'Praecipe for Self-Representation,' check the first box if you have never been represented by an attorney in connection with this custody case and check the second box if you previously had an attorney represent you in connection with this case (Note: If you currently have an attorney representing you in connection with this custody case and wish to keep your attorney then you should not use the packet - your attorney can create all of the necessary forms for you). The address you include below the signature line on Page 3 is the address the court and the other party are supposed to use to send legal papers to you. Make sure the court and all other parties always have your current mailing address for legal papers because you will be treated as if you received any mail sent to you at the address you provide. If you do not keep your mailing address updated, you may miss important notices and fail to receive important legal documents. The court provides a separate stand-alone 'Praecipe to Update Contact Information' form that you can use later on to inform the court and other parties of any changes in your contact information.

<u>Page 3, Verification and Signature</u> — After you have filled out the rest of the Petition to Modify Custody, sign and date the last page. By signing the Petition to Modify Custody and filing it with the court you are asserting that the information you provide is true and correct to the best of your knowledge, information, and belief. If you intentionally provide false information in a document you submit to the court, you may be subject to criminal charges under 18 PA. C.S.A. § 4904.

#### STEP 2: COMPLETE THE CRIMINAL RECORD/ABUSE HISTORY VERIFICATION FORM

You will also need to prepare a Criminal Record/Abuse History Verification Form. You will need to do this even if you have filled one out before. Begin by filling in the case caption at the top of the first page the same way you filled in the captions on the first page of the Petition to Modify Custody. Next, print your name in the blank space on the first page. This form contains a long list of crimes and offenses that the

court may consider when making a custody decision. You are required to disclose if you or any other member of your household has ever been convicted of any of these crimes or offenses. You must also disclose if either you or any other member of your household is currently facing charges for any of these crimes or offenses, even if you have not yet been convicted. For each crime or offence listed, provide the requested information. Here are some examples:

The last page of the form requests additional information about any counseling, evaluations, or treatment you may have received as a result of any of the crimes or offences listed, as well as additional information about any applicable household member. You should also disclose if the Respondent or members of the Respondent's household has or have a criminal or abuse history

After you have filled out the Criminal Record/Abuse History Verification Form, sign and date the last page. By signing this form and filing it with the court you are asserting that the information you provide is true and correct to the best of your knowledge, information, and belief. If you intentionally provide false information, or knowingly fail to disclose any applicable crimes or offences, you may be subject to criminal charges under 18 PA. C.S.A. § 4904.

#### STEP 3: PREPARE THE PROPOSED NOTICE AND ORDER FOR THE COURT

You will also need to prepare the proposed 'Notice and Order' for the court. You should fill in the case caption at the top of the Notice and Order the same way did on the first page of the Petition to Modify Custody. You should also fill in your name and the Respondent's name in the Distribution list at the bottom left side of the Notice and Order. You should <u>not</u> fill in the date of the conference or sign the Notice and Order. The date is set by the Court and the Notice and Order will be signed by the judge.

IF THE COURT HAS PREVIOUSLY APPOINTED A GUARDIAN AD LITEM IN YOUR CASE, YOU MUST ADD THEIR NAME TO THE DISTRIBUTION LIST AT THE BOTTON THE NOTICE AND ORDER. FAILURE TO INCLUDE THE GUARDIAN AD LITEM IN THE DISTRIBUTION LIST MAY RESULT IN DELAYS IN HEARING YOUR CASE.

#### **STEP 4: PREPARE COPIES OF YOUR DOCUMENTS**

Before you go to court, you will need to make copies of the Petition to Modify Custody, Criminal Record/Abuse History Verification Form, and the Notice and Order. You will need at least two copies of the Petition to Modify Custody, two copies of the completed Criminal Record/Abuse History Verification Form, and at least two copies of the Notice and Order. You will also need an additional blank copy of the Criminal Record/Abuse History Verification Form to send to the Respondent. When you go to the courthouse you will need to bring with you the following:

- -One (1) original Petition to Modify Custody and two (2) copies of the Petition to Modify Custody,
- **-One (1) original** completed Criminal Record/Abuse History Verification Form and **two (2) copies** of the completed and signed Criminal Record/Abuse History Verification Form,
- -One (1) original proposed Notice and Order and two (2) copies of the proposed Notice and Order.

Note: If there is more than one Respondent, you will need to bring an extra copy of each of the above documents for every additional Respondent. You will also need to bring an extra copy of each of the above documents if there is a Guardian Ad Litem.

#### **STEP 5: FILE YOUR DOCUMENTS**

Now you can go to the Prothonotary's office in the courthouse. Tell the staff that you are there to file a Petition to Modify Custody and give them your papers. The Prothonotary's Office will take your original Petition to Modify Custody and Criminal Record/Abuse History Verification Form and keep them for the court file. They will also timestamp the copies of the Petition to Modify Custody and Criminal Record/Abuse History Verification Form and give the copies back to you. They will keep the original proposed Notice and Order and both copies of the Notice and Order.

#### STEP 6: SERVE YOUR DOCUMENTS ON THE DEFENDANT

The court will add a date and time for the preliminary custody conference to the Notice and Order and the judge will sign it. After the Notice and Order is signed by the judge, copies will be mailed to you and the Respondent(s) at the addresses you provided.

It is nonetheless **your responsibility** to send each Respondent (1) a copy of the Petition to Modify Custody (2) a copy of your completed and signed Criminal Record/Abuse History Verification Form, (3) a copy of the Notice and Order after the court has assigned a date for the custody conference and returned the form to you, and (4) a blank Criminal Record/Abuse History Verification Form for each Respondent to complete and file. You must mail these documents by certified mail, restricted delivery, return receipt requested. If you do not know how to complete the postal "green card," the post office can assist you. When you mail something by certified mail, restricted delivery, return receipt requested, the person must sign for their mail in order to get it. A green card with the person's signature is then returned to you. You will need the green card with each Respondent's signature to prove that each Respondent received the

documents that you sent them. If you have an open Children and Youth Services case, you must also send copies of your documents to the Children and Youth Services agency.

#### STEP 7: FILE YOUR CERTIFICATE OF SERVICE

When you receive a signed green card back from the Respondent, you will need to attach it to the 'Certificate of Service' and file it at the Prothonotary's Office. Fill in the case caption at the top of the Certificate of Service the same way you filled in the case caption on all of your other documents (only this time you should already have the docket number, so you can fill in the docket number yourself). Attach the postal green card to the Certificate of Service using glue or tape with the side containing the Respondent's signature facing up. Then you should sign and date the Certificate of Service. You can then take it back to the Prothonotary's office and file it as part of your case record. You should also make a copy for your own records. **Do not file the Certificate of Service unless and until you have attached the postal green card**. If you do, you will actually be committing a crime because the form itself certifies under potential legal penalties that the signed green card is attached. You will need to file a separate Certificate of Service for every Respondent.

NOTE: IT IS YOUR RESPONSIBILITY TO CONFIRM THAT EACH RESPONDENT HAS RECEIVED NOTICE OF THE PRELIMINARY CUSTODY CONFERENCE. If you do not file a Certificate of Service with a Respondent's signature, and the Respondent does not appear for the preliminary custody conference, the court will probably reschedule the case so that you can serve your papers on the Respondent and provide proof of the same. This may significantly delay your case. If the Respondent does not accept their mail, you may need to pay the Sheriff's office or a constable to serve the papers for you, or you may need to talk to a lawyer about other service options.

#### STEP 8: GO TO THE PRELIMINARY CUSTODY CONFERENCE

You and the Respondent(s) are required to attend to the preliminary custody conference. The preliminary custody conference is not a full hearing, and you will not be permitted to call any witnesses or present any evidence. You should not bring children to the preliminary custody conference unless the court directs you to do so. The primary purpose of the preliminary custody conference is to see if you and the Respondent(s) can reach an agreement. If you can reach an agreement then no further action will be required. Otherwise, the court will give you further instructions.
